



## Statement of CM2 Intellectual Property Ownership and Exclusive Rights

This document formally declares the ownership of intellectual property (IP) related to CM2 training and content, and the exclusive rights for its licensing and provision within the country of Türkiye.

### 1. Ownership of Intellectual Property
